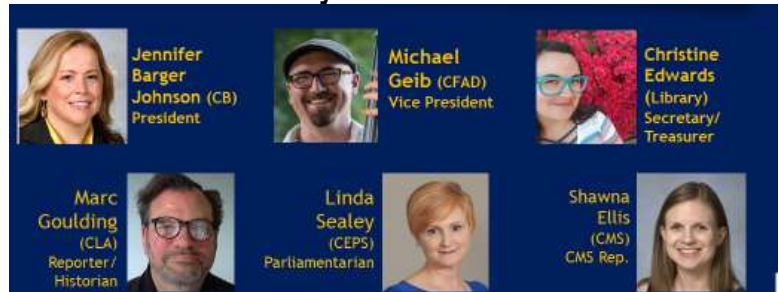

# FACULTY SENATORS

Faculty senators are elected for two-year terms in the spring from each of the five colleges and also include representatives from the library, advising, and professional administration. Faculty Senators serve as a deliberative body representing the voice of the Faculty Association.
