FACULTY SENATORS

Faculty senators are elected for two-year terms in the spring from each of the five colleges and also include representatives from the library, advising, and professional administration. Faculty Senators serve as a deliberative body representing the voice of the Faculty Association. The Faculty Senate works closely with the administration of UCO, Staff Senate, and UCOSA to create change and support the faculty and the UCO community. The Faculty Senate Executive Committee consistently meets with President Neuhold-Ravikumar and the Interim Provosts Simmons and Steward, and the Faculty Senate President attends the Faculty Handbook Editorial Board, Provost's Advisory Council, University Planning Committee, and President's Faculty Advisory Council meetings.
